## POLICY #19

## NOTIFICATION OF ABSENCE WITHOUT VALID CAUSE K-8

This 'Notification of Absence' policy requires A) attendance centers housing special education students from out-of-district to follow the below procedures and B) home districts to initiate parent contacts.

- A. In the event a Henry-Stark Counties Special Education District teacher reports an out-ofdistrict student absent, without valid cause, the person in the attendance center charged with the responsibility of calling parents shall:
  - 1) notify the home district of each absent out-of-district student, informing the contact person from the home district of the student's absence
  - 2) provide notification to the home district within two hours after the first class
- B. Upon notification of a student absence by a Henry-Stark Counties Special Education District attendance center, the student's home district shall make reasonable efforts to telephone and notify the parent within the first two hours following the first class.
