HENRY-STARK COUNTIES SPECIAL EDUCATION DISTRICT

FULL EDUCATIONAL OPPORTUNITY GOAL

**Requirement:** 34 C.F.R. 300.222 "Each application must: (a) include a goal of providing full educational opportunity will be provided to all disabled children, aged birth through 21, and (b) include a detailed timetable for accomplishing the goal."

**Federal:** 34 C.F.R. Part 300

**State:** 226.Subchapter f: Specific Student Populations


- A. The Henry-Stark Counties Special Education District has established a goal that a full educational opportunity will be provided to each disabled child, ages birth through twenty-one years of age, regardless of the severity of the child's handicap. A resolution of the Executive Board formally adopting the goal was passed on January 25, 1990.
- B. Attainment of the full educational opportunity goal will be in accordance with the State plan provisions responsive to the requirement of 34 CFR at 300.125.
- C. The Director of Special Education will be responsible for ensuring that the full educational opportunity goal is fully achieved and shall take whatever actions are necessary to that end.
- D. The Henry-Stark Counties Special Education District annually collects the following information regarding disabled children:
  - 1. the number of disabled children aged birth through twenty-one years in need of special education and related services;
  - 2. the number of disabled children receiving special education and related services; and,
  - 3. the number of disabled children in need of expanded services.
- E. The Henry-Stark Counties Special Education District annually collects the following information regarding the facilities, personnel, and services necessary to accomplish the full educational opportunity goal, including regular class, resource room, special class, special school, private day and residential schools and facilities, public residential facilities, and home-bound instructional settings:
  - 1. the number of disabled children,
  - 2. the number of teachers,
  - 3. the number of related services personnel,
  - 4. the cost of all personnel, and
  - 5. transportation requirements.
