## RESOLUTION OF THE GOVERNING BOARD OF HENRY-STARK COUNTIES SPECIAL EDUCATION DISTRICT 801

#### AUTHORIZING THE TRANSFER OF CERTAIN REAL PROPERTY AND GRANT OF PERMANENT AND TEMPORARY CONSTRUCTION EASEMENTS TO THE STATE OF ILLINOIS, DEPARTMENT OF TRANSPORTATION

**WHEREAS**, the Governing Board of Henry-Stark Counties Special Education District 801 (hereinafter referred to as the "**Board**"), is the owner of real property located at 1318 W. 6<sup>th</sup> Street, Kewanee, IL 61443 (hereinafter referred to as the "**Real Estate**"); and

**WHEREAS,** the State of Illinois desires to acquire fee simple title to approximately 744 square feet of the Real Estate, legally described on Exhibit A attached hereto, for highway purposes (hereinafter referred to as the "**Acquired Property**"); and

**WHEREAS**, the State of Illinois has offered the Board \$4,500 to purchase the Acquired Property; and

WHEREAS, the State of Illinois further desires to acquire a four-year temporary construction easement on approximately 5,002 square feet of the Real Estate, legally described on Exhibit B attached hereto, for the use of the Department of Transportation for grading, driveway construction, and other highway purposes (hereinafter referred to as the "Temporary Construction Easement") and has offered the Board \$20,000 for the Temporary Construction Easement; and

WHEREAS, the State of Illinois further desires to acquire a permanent easement on approximately 1,196 square feet of the Real Estate, legally described on Exhibit C attached hereto, for the use of the Department of Transportation for retaining wall maintenance and for other highway purposes (hereinafter referred to as the "Permanent Easement") and has offered the Board \$1,800 for the Permanent Easement; and

**WHEREAS**, the Board has determined that it is in the best interest of the School District to accept the State of Illinois' offer for the Acquired Property, Temporary Construction Easement, and Permanent Easement; and

WHEREAS, the Board has the authority to sell the Acquired Property and grant the Temporary Construction Easement and Permanent Easement described above to the Illinois Department of Transportation in accordance with Sections 5-22 and 5-29 of the School Code (105 ILCS 5/5-22 and 105 ILCS 5/5-29) and Section 3 of the Local Government Property Transfer Act (50 ILCS 605/3 et seq.); and

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Board of Henry-Stark Counties Special Education District 801, as follows:

Section 1:	inconvenient for the uses of Henry-Stark Counties Special Education District 801.		
Section 2:	The Board authorizes transfer of the Acquired Property and grant of the Temporary Construction Easement and Permanent Easement to the Illinois Department of Transportation, in substantially the forms provided in Exhibits A, B, and C hereto. The Board further authorizes the execution and delivery of such other instruments as may be necessary or convenient to consummate such transfer, subject to the approval of the Board's legal counsel.		
Section 3:	The President of the Board is authorized to sign the deed of conveyance for the Acquired Property on behalf of the Board, and the Executive Director or designee is authorized to sign any other documents necessary to complete the transfer of the Acquired Property and grant of the Temporary Construction Easement and Permanent Easement contemplated by this Resolution.		
Section 4:	All resolutions or parts of resolutions in conflict with this Resolution are repealed, and this Resolution shall be in full force and effect immediately and forthwith upon its passage.
