

## **SCHOOL RESOURCE OFFICER EMPLOYMENT**

### **INTERGOVERNMENTAL AGREEMENT**

Agreement by and between the Village of Atkinson, Illinois, whose principal business address is 107 W Main St, Atkinson, Henry County, Illinois, 61235, hereinafter referred to as "Village", and the ExCel School, of the Henry-Stark County Special Education District, whose principal address is 105 S State St, Atkinson, Henry County, Illinois, 61235 hereinafter referred to as "School".

### **RECITALS**

- A. The Village of Atkinson has entered into an Intergovernmental Agreement with the Henry-Stark County Special Education District to provide a School Resource Officer (SRO) to the School, hereinafter referred to as "the Agreement".
- B. The Village and the School have all agreed that part-time SRO services will be provided by the Village, using part-time Atkinson Police Department police officers, and/or the Chief of Police, to provide coverage within the School during operating hours.
- C. The SRO will provide services to the School, as well as services to the Village if necessary, upon the discretion of the SRO or under the direction of the Chief of Police.

NOW, THEREFORE, for good and valuable considerations the receipt of which are hereby acknowledged, the Village and the School agree to the following terms and conditions:

- 1. **TERM**. The term of the Agreement shall commence on August 13<sup>th</sup>, 2025, the first day of school, and shall end on the last day of school, which will be determine on a later date, unless sooner terminated according to the terms of this Agreement. At the end of the term or if this Agreement is terminated for any reason, this Agreement shall be of no force and affect in any manner whatsoever and all terms of this Agreement shall be null and void upon termination, except as otherwise provided herein.
- 2. **COMPENSATION**. The SRO position shall be paid the sum of \$23.50 per hour (for part-time police officers) and \$54.08 per hour (for the Chief of Police) as provided in the Agreement. All the compensation charges shall be reimbursed to the Village by the School for the term of this Agreement. Compensation will be payable on dates as all other Village employees and any renewal or change shall be established by written agreement of the School and the Village.

3. RESPONSIBILITIES. The responsibilities of the SRO shall include providing services to the School which include general law enforcement duties, as well as providing safety, security, and liaison to all staff and students.
4. RIGHT TO HEARING. Except as otherwise provided herein, all terms and conditions of the Village Personnel Policy Manual shall apply to the SRO as a part-time employee of the Village, excluding the Chief of Police, being a full-time employee of the Village.
5. TERMINATION. In the event that either the School or the Village desires to terminate this Agreement, either party shall submit written notice of termination thirty (30) calendar days prior to the date the termination will take effect. The day on which the notice is submitted shall be considered the first date of such notice.

WHEREFORE, the parties hereto have signed this Agreement that day and year set opposite their signature.
