INDEPENDENT CONTRACTOR AGREEMENT

THIS AGREEMENT entered into this 14th day of February 2019 between Adam Burroughs and the Henry-Stark Counties Special Education District Counties Special Education District.

RECITALS

- 1. Henry-Stark Counties Special Education District is a Joint Agreement of Illinois public school districts, operating pursuant to its Articles of Joint Agreement, as provided in Section 10-22.31 of the Illinois School Code. Henry-Stark Counties Special Education District operates through a governing board.
- 2. Adam Burroughs is a sworn Officer of the Law. Henry-Stark Counties Special Education District wishes to engage Adam Burroughs as a Liaison Officer for Henry-Stark Counties Special Education District ExCEL Program, and Adam Burroughs is willing to provide these services as an independent contractor, on the terms set forth herein.
 - **NOW, THEREFORE,** in consideration of the undertakings hereinafter made, the parties hereto agree as follows:
- 1. Henry-Stark Counties Special Education District hereby contracts with Adam Burroughs for the following services for Henry-Stark Counties Special Education District:
 - Type of Services Liaison Police Officer Services.

<u>Time to be Performed</u> The dates and times Adam Burroughs will work will be determined by mutual agreement and in cooperation with the other independent liaison police officer contractors. A master work schedule will be held by the Principal of the ExCEL Program. The master schedule will be for no more than a maximum of 30 hours per week for the time period the first student attendance day of the 2018-2019 school year through the last day of 2018-2019 student attendance.

<u>Place to be Performed</u> ExCEL Program, 105 S State Street, Atkinson Illinois.

<u>Termination of Contract</u> This agreement may be terminated by either party with thirty (30) days written notice.

- 2. <u>Compensation for Services</u> For the performance of these services Adam Burroughs shall be paid \$18.50 per hour.
- 3. <u>Payments</u> Payments by Henry-Stark Counties Special Education District to Adam Burroughs shall be made monthly, in accordance with Henry-Stark Counties Special Education District's regular practices, and following submission by Adam Burroughs of required time sheets to the Henry-Stark Counties Special Education District Administration Office.

- 4. Specialized Knowledge Henry-Stark Counties Special Education District recognizes that Adam Burroughs possesses specialized knowledge and abilities in law enforcement, and in the performance of the services herein undertaken. Adam Burroughs shall not be subject to the direction or supervision of any employee of Henry-Stark Counties Special Education District, rather, Adam Burroughs shall carry out the services to be provided as Adam Burroughs deems proper. Adam Burroughs will be provided with a copy of the most recent Crisis Response Guide for the ExCEL School by the Building Principal.
- 5. <u>Independent Contractor</u> Adam Burroughs shall be an independent contractor, and not an employee. Adam Burroughs shall be solely responsible for the payment of all taxes and Henry-Stark Counties Special Education District shall make no deduction or withholding for taxes or other governmentally required payments or contributions for or in respect to Adam Burroughs. Adam Burroughs shall not be eligible for any benefits, privileges, or other compensation applicable to employees of Henry-Stark Counties Special Education District, or any member school district, specifically including, but not limited to health benefits or worker's compensation benefits of any kind.
- 6. <u>Police Professional Liability Insurance</u> Henry-Stark Counties Special Education District shall at all times maintain at the expense of the Henry-Stark Counties Special Education District a Police Professional Liability Insurance policy naming Adam Burroughs as insured at levels of coverage which Henry-Stark Counties Special Education District will determine necessary.
